INSTRUCTIONS FOR APPLICANTS

medical examination process

BEFORE YOU ARRIVE

Your employer will arrange your medical examination and submit the completed referral form to the Institute.

■ FOR EXAMINATIONS IN RIJEKA

For an examination in Rijeka, the referral form should be emailed to: stranci@zzjzpgz.hr

■ FOR EXAMINATIONS AT A BRANCH OFFICE

For an examination at a branch office, the referral form should be emailed to the branch where you will undergo the examination:

1. BRING THE FOLLOWING WITH YOU

- your passport or another identification document
- the completed referral form from your employer
- proof of payment for the examination and required tests
- your medical records and vaccination records, if available
- a stool sample

2. REPORT TO THE TEACHING INSTITUTE OF PUBLIC HEALTH OF PRIMORJE-GORSKI KOTAR COUNTY

■ IF YOUR MEDICAL EXAMINATION IS IN RIJEKA

Upon arrival at the Teaching Institute of Public Health of Primorje-Gorski Kotar County, **Krešimirova 52a**, Rijeka ([View on map](#)), please report to **counter 4 or 5** of the Department of Epidemiology of Infectious and Chronic Non-communicable Diseases. The counters are on the ground floor, to the right.

The medical examination takes place in **Examination Room 5**.

After the examination, a member of staff will direct you to the laboratory tests and, if required, a chest X-ray.

■ IF YOUR MEDICAL EXAMINATION IS AT A BRANCH OFFICE

Medical examinations are available at the branch offices in Cres, Opatija, Krk, Delnice, Mali Lošinj and Rab.

3. COMPLETE THE LABORATORY TESTS

■ IF YOUR MEDICAL EXAMINATION IS IN RIJEKA

After the medical examination, remain on the ground floor, turn left and report to **counter 2**.

There you will:

- submit a stool sample (*for applicants arriving from Asia, Africa or South America*)
- have a blood sample taken (*for all applicants*)

■ IF YOUR MEDICAL EXAMINATION IS AT A BRANCH OFFICE

Branch staff will tell you where to complete the required laboratory tests.

***Note:** The doctor may request additional tests or vaccination if needed. If Salmonella is detected in the stool sample, an additional identification test is required. This test is charged separately according to the current price list.*

4. HAVE A CHEST X-RAY

■ IF YOUR MEDICAL EXAMINATION IS IN RIJEKA

You will be referred for a chest X-ray at:

■ IF YOUR MEDICAL EXAMINATION IS AT A BRANCH OFFICE

During the examination, you will be told where you can have the chest X-ray.

5. RETURN TO THE TEACHING INSTITUTE OF PUBLIC HEALTH OF PRIMORJE-GORSKI KOTAR COUNTY

Once you have completed all required tests, return in person to the Institute or the branch office where you had your medical examination.

When the medical examination and all required tests are complete, you will receive the documents needed to extend your temporary stay.

***Note:** The cost of the medical examination is covered by your employer. The documents are issued after proof of payment has been submitted.*
